Thank you for your email regarding last week's vote on Environmental Impact Assessments (EIAs.)

I voted in favour of mandatory Environmental Impact Assessments, to be carried out both for the exploration and production phases of all unconventional fossil fuel projects. I also voted in favour of the report as a whole and voted to maintain and strengthen the ability of the public to access information regarding EIAs.

The fact that the right-wing in the Parliament wanted to remove even such a limited provision, demonstrates that the fight against fracking must continue. It is positive to see such good work being done by campaigners on this issue - it clearly has had an effect. We need to push now for a full ban on fracking and for public investment in green technology as an environmentally friendly alternative.

Thank you for your emails regarding the Zanoni Report which will be voted on tomorrow in Strasbourg. I have already sent a short email informing you of the delay on the vote last month.

I will be voting in favour of amendments **31 and 79** which call for a mandatory environmental impact assessment to be carried out for both the exploration and production phases of all unconventional fuel projects. I will also vote **against amendment 112**. There may be some other amendments which will only be available on Monday and I will keep a close eye to ensure coherence in my voting.

Some of you I know are very interested in the cross-border aspect and there are a number of amendments (**2, 4, 17, 30, 32, 41, 59, 67, & 116**) which I have attached for your information on this issue. I will be supporting these amendments. They may give some minimum level of protection in cross border areas.

There are also a number of amendments on public health (**Amendments 1, 54, 81, 82, 83, 101, 103, 113 & 129**) which I will also be supporting and I attach them above for your information.
